**Yearly Tuition Fees paid in full by 10 February 2024 will receive a 2% discount.**

### Sibling discount

This applies to tuition fees for families with more than one student enrolled at the school at the same time:

Second Child – 5%

Third Child – 25%

Fourth Child or over – 50%

### Enrolment Application Fees

First child \$110      Subsequent children \$90

### Enrolment Acceptance Fee

A sum of \$2,500 is payable for each new student entering the School. This fee is due on confirmation of enrolment and is non-refundable.

### Service Levy

All known compulsory charges applicable to a whole year group in 2024 have been incorporated into a service levy and the costs spread over the year. This allows for more certainty over the cost of the student's education and assists families with budgeting. This levy is not refundable, and credits will not be issued from failure to participate in compulsory activities.

### Camps, Outdoor Education and Elective Subject Levies

These charges will be determined at the start of each calendar year. Camp Levies and Outdoor Education will be charged over four terms, whereas Subject Levies where possible, will be billed in Term Two.

### Notice of Withdrawal of Student

Attention is directed to the necessity of giving the Principal **a full term's notice in writing** of the intention to withdraw a student from the School. In default of such notice, one term's fees will be payable (+GST)

### Policy Changes

The Council of Northholm Grammar may, at its discretion, amend or discontinue any existing policy or procedure; or introduce a new policy or procedure, to respond to changes in legislation or as it deems necessary from time to time. You are invited to contact Northholm Grammar's Enrolments Office at any time to seek clarification of any changes to the School's Enrolment Policy which may have occurred.

*The School Council reserves the right to alter fees, conditions, and charges at any time.*

## **Payment of Fees and Other Charges**

### **Term Fees**

Fees are due and payable at the start of each term and are invoiced four times a year (over three terms for Year 12). A final account is issued to parents in December for any incidentals during term four.

### **Co-Curricular Music**

Students choosing to participate in the co-curricular music program will be charged a fee of \$155 per term. Individual instrument tuition is available in the School and details of fees are given on request. Payment of fees is an arrangement between the tutor and family involved.

### **Capital Levy**

A fee of \$300 per family per term is charged and funds raised go towards building and grounds improvements.

### **Voluntary Building Fund Donation**

Parents are invited to make voluntary contributions to the Building Fund. These contributions are tax deductible. A receipt for tax purposes will be issued in July of each year. The suggested amount of a minimum of \$150 per family will appear on each statement. Amounts donated to the Building Fund are used for new buildings and major refurbishments.

### **The Northholm Association Levy**

All parents are eligible for membership of the Northholm Association and the amount of \$100 per family will be charged to the account in Term 2.

### **Camps, Outdoor Education, Elective Subject Levies and Ad hoc Activities**

Charges for camps and elective subjects will be determined closer to the commencement of the new school year. There may be occasions where an opportunity arises for an additional excursion or activity. This amount will be charged separately on the family fee account.

### **Student Accident Insurance**

All students enrolled at Northholm are covered by an accident insurance policy and details are available on the website.

### **Overdue Charge**

An overdue charge of \$120 may be added to accounts where fees are overdue and no arrangement for payment has been made with the Finance Office. This charge is a rate determined by the School from time to time and is a genuine pre-estimate by the School of the loss that it would suffer if fees were not paid by the due date.

## **2024 MONTHLY DIRECT DEBIT OPTION**

The School has a system of monthly direct debits for the payment of fees. The advantage of such a system is that payments are spread evenly throughout the year, thus minimising the financial burden at the start of each term. You will need to provide the School with an authority to draw one tenth of the annual fees for your family from a nominated bank account each month. These regular payments will commence in February and conclude in November each year. Any balance remaining on the account as a result of additional co-curricular charges will be debited on the 15 December.

Any bank fee related to monthly direct debit rejections may be charged back to fee accounts. If you are already participating in the direct debit system and have students enrolled for 2024 the arrangements will be extended automatically.
